- English corresponding to the level of English in Swedish upper secondary education (Engelska 6).

Intended learning outcomes

On completion of the course, the students should on an advanced level be able to:

- describe and analyse concepts, theories, and issues within the field of the philosophy of medicine
- develop an argument based on theory in specific problem areas related to philosophical questions in medicine
- formulate theory-based descriptions of philosophical questions in medicine
- formulate theory-based political recommendations to solve philosophical problems in medicine
- apply a critical approach to positions and arguments

Course content

The philosophy of medicine is the study of philosophical problems that arise from medical practices. The course introduces the research area of the philosophy of medicine through concrete questions for policymakers. Central theories within the philosophy of medicine are covered in the course, with examples of central theoretical frameworks being the principles discussed in the medical-ethical literature. Theories are applied to concrete problems for policymakers. The theories are critiqued and evaluated in relation to their practical consequences. Methods for developing policy within medical practices are discussed in light of these consequences.

Teaching and working methods

The course includes lectures, group discussions, writing assignments, seminars, and workshops. Students are also expected to engage in self-study.

Language of instruction and examination: English.

Examination

The course is examined through:

- active participation in seminars, grading scale: UG
- individual book review, grading scale: UG
- individual written assignment, grading scale: EC
- active participation in workshops, grading scale: UG

To get Pass (E) as the final grade, at least an E is required on the individual written assignment and a Pass on the other components. Higher grades are based on the individual written assignment.

If special circumstances prevail, and if it is possible with consideration of the nature of the compulsory component, the examiner may decide to replace the compulsory component with another equivalent component.

If the LiU coordinator for students with disabilities has granted a student the right to an adapted examination for a written examination in an examination hall, the student has the right to it.

If the coordinator has recommended for the student an adapted examination or alternative form of examination, the examiner may grant this if the examiner assesses that it is possible, based on consideration of the course objectives.

An examiner may also decide that an adapted examination or alternative form of examination if the examiner assessed that special circumstances prevail, and the examiner assesses that it is possible while maintaining the objectives of the course.

Students failing an exam covering either the entire course or part of the course twice are entitled to have a new examiner appointed for the reexamination.

Students who have passed an examination may not retake it in order to improve their grades.

Other information

Planning and implementation of a course must take its starting point in the wording of the syllabus. The course evaluation included in each course must therefore take up the question how well the course agrees with the syllabus.

About teaching and examination language

The teaching language is presented in the Overview tab for each course. The examination language relates to the teaching language as follows:

- If teaching language is “Swedish”, the course as a whole could be given in Swedish, or partly, or as a whole, in English. Examination language is Swedish, but parts of the examination can be in English.
- If teaching language is “English”, the course as a whole is taught in English. Examination language is English.
- If teaching language is “Swedish/English”, the course as a whole will be taught in English if students without prior knowledge of the Swedish language participate. Examination language is Swedish or English depending on teaching language.
