## Entry requirements

- Bachelor's degree equivalent to a Swedish Kandidatexamen of 180 ECTS credits in one of the following subjects:
  - statistics
  - mathematics
  - applied mathematics
  - computer science
  - engineering
- Passed courses in
  - calculus
  - linear algebra
  - statistics
  - programming
- English corresponding to the level of English in Swedish upper secondary education (Engelska 6)  
Exemption from Swedish
- At least 24 ECTS credits passed in the main field of Statistics at second cycle and at least 5 ECTS credits passed in the main field of Computer Science at second cycle

## Intended learning outcomes

After completion of the course, the student should at an advanced level be able to:

- apply data mining or machine learning in a real setting
- plan, perform and report on an individual task
- discuss research and development work within machine learning or related areas

## Course content

The content of the course is adapted to the addressed problem. The student joins an ongoing research project within statistics, machine learning, data mining or a related field, where the origin of the problem and the research related to it are studied, and where the given problem is analyzed by using methods in the field.

## Teaching and working methods

The work is performed individually with support and guidance of a supervisor. Language of instruction: English.

## Examination

The course is examined by:

- individual written project report, grade scale: EC
- individual oral presentation, grade scale: EC

For Pass (E) as the final grade, at least E is required on both examination parts. Higher grades are also based on both examination parts.

Detailed information can be found in the study instructions.

If special circumstances prevail, and if it is possible with consideration of the nature of the compulsory component, the examiner may decide to replace the compulsory component with another equivalent component.

If the LiU coordinator for students with disabilities has granted a student the right to an adapted examination for a written examination in an examination hall, the student has the right to it.

If the coordinator has recommended for the student an adapted examination or alternative form of examination, the examiner may grant this if the examiner assesses that it is possible, based on consideration of the course objectives.

An examiner may also decide that an adapted examination or alternative form of examination if the examiner assessed that special circumstances prevail, and the examiner assesses that it is possible while maintaining the objectives of the course.

Students failing an exam covering either the entire course or part of the course twice are entitled to have a new examiner appointed for the reexamination.

Students who have passed an examination may not retake it in order to improve their grades.

## Other information

### **About teaching and examination language**

The teaching language is presented in the Overview tab for each course. The examination language relates to the teaching language as follows:

- If teaching language is “Swedish”, the course as a whole could be given in Swedish, or partly, or as a whole, in English. Examination language is Swedish, but parts of the examination can be in English.
- If teaching language is “English”, the course as a whole is taught in English. Examination language is English.
- If teaching language is “Swedish/English”, the course as a whole will be taught in English if students without prior knowledge of the Swedish language participate. Examination language is Swedish or English depending on teaching language.
