## **Entry requirements**

For admission to the course, apart from the general entry requirements, the student is required to satisfy the entry requirements that apply for admission to the Commercial and Business Law Programme or to the Commercial and Business Law Programme with Focus on Europe. In addition, the student should have completed the following courses (or the equivalent); Tax Law, Theories and Methods of Law, Public and EU Law, Contract, Tort and Insurance Law, and completed Bachelor Thesis, 15 HE credits, with a passing grade.

## Intended learning outcomes

On completion of the course, the student should be able to

- account for the judicial regulations of the common market and their function,
- demonstrate in-depth knowledge about and understanding of the practices of the European Court of Justice,
- in an independent and qualified way analyse the implications and effects of relevant legal rules,
- analyse, discuss and draw conclusions about the practices of the European Court of Justice in a for the area relevant issue with a scholarly approach, both in writing and orally,
- reflect on and evaluate the conclusions drawn,
- demonstrate in-depth understanding of the dynamic nature of the European Court of Justice.

#### Course content

The course contains both study and analysis of the economic and judicial bases of the common market. The focus is on the free mobility of goods, services, employees, companies and capital, and on the competition rules. This includes indepth analyses and discussions of the interpretation methods and practices of the European Court of Justice.



## Teaching and working methods

Teaching mainly takes the form of lectures and seminars. The seminars are mainly carried out in small groups, where there are substantial demands on the student's activity. The student is largely expected to apply self-study, based on the course material that is supplied in preparation for the seminars. In the seminars, the knowledge acquired through self-study should be strengthened, developed and advanced through reviews and discussions.

#### **Examination**

The course is examined through submission of an independent essay, to be presented orally. In addition, examination takes place through written individual examination.

If special circumstances prevail, and if it is possible with consideration of the nature of the compulsory component, the examiner may decide to replace the compulsory component with another equivalent component.

If the LiU coordinator for students with disabilities has granted a student the right to an adapted examination for a written examination in an examination hall, the student has the right to it.

If the coordinator has recommended for the student an adapted examination or alternative form of examination, the examiner may grant this if the examiner assesses that it is possible, based on consideration of the course objectives.

An examiner may also decide that an adapted examination or alternative form of examination if the examiner assessed that special circumstances prevail, and the examiner assesses that it is possible while maintaining the objectives of the course.

Students failing an exam covering either the entire course or part of the course twice are entitled to have a new examiner appointed for the reexamination.

Students who have passed an examination may not retake it in order to improve their grades.

## Other information

Planning and implementation of a course must take its starting point in the wording of the syllabus. The course evaluation included in each course must therefore take up the question how well the course agrees with the syllabus.
