### **Entry requirements**

- Bachelor's degree equivalent to a Swedish Kandidatexamen
- At least 5 ECTS credits passed in Methods
- At least 5 ECTS credits passed in Social Sciences
- English corresponding to the level of English in Swedish upper secondary education (Engelska 6)
  Exemption from Swedish

### Intended learning outcomes

After completing the course, the student should on an advanced level be able to:

- identify and account for how ageing and social change is managed in the political dialogue and in scientific research in a Scandinavian and European context
- discuss issues of aging and social change within policy and scientific research
- independently identify and formulate research questions in policy-oriented research in Ageing and social change
- discuss methods and conclusions orally and in written form
- assess methods addressing social aspects of ageing in policy-oriented research, its limitations, and roles in society
- apply ethical aspects in research within Ageing and social change

#### Course content

In the course, an overview of research and related policies within Ageing and social change is presented, its history, participants, institutions, funding schemes, as well as access to and availability of research resources such as data. In the course, the principles of basic research and policy-oriented research in the field of ageing is introduced. Moreover, the scientific and political discourse in Scandinavia and at a European level as well as research methods within ageing policies, are discussed and integrated. Research ethics and ethical considerations in societal issues are addressed.

### Teaching and working methods

The course includes a hybrid teaching model where students meet simultaneously on site and online for lectures and work together in workshops and seminars. This course includes mandatory on campus periods. In addition, the student should conduct self-study and work with others in peer learning groups.



#### **Examination**

Students admitted to the online programme are examined online, students admitted to on campus programme are examined on campus. In addition, there are on campus weeks, where all the students are examined on campus, see note CAMPUS.

The course is examined through:

- active participation in seminars, grading scale: pass/fail
- active participation in workshops, CAMPUS, grading scale: pass/fail
- active participation in seminars, CAMPUS, grading scale: pass/fail
- written report (individual) and verbal feedback, CAMPUS, grading scale: ECTS
- written examination (group), grading scale: pass/fail

For a passed final grade (E), a pass is required on all examinations and an E on written report (individual) and verbal feedback. Higher grades are based on written report (individual) and verbal feedback.

Detailed information about the examination can be found in the study guide.

If special circumstances prevail, and if it is possible with consideration of the nature of the compulsory component, the examiner may decide to replace the compulsory component with another equivalent component.

If the LiU coordinator for students with disabilities has granted a student the right to an adapted examination for a written examination in an examination hall, the student has the right to it.

If the coordinator has recommended for the student an adapted examination or alternative form of examination, the examiner may grant this if the examiner assesses that it is possible, based on consideration of the course objectives.

An examiner may also decide that an adapted examination or alternative form of examination if the examiner assessed that special circumstances prevail, and the examiner assesses that it is possible while maintaining the objectives of the course.

Students failing an exam covering either the entire course or part of the course twice are entitled to have a new examiner appointed for the reexamination.

Students who have passed an examination may not retake it in order to improve their grades.

## Other information

Planning and implementation of a course must take its starting point in the wording of the syllabus. The course evaluation included in each course must therefore take up the question how well the course agrees with the syllabus.

#### About teaching and examination language

The teaching language is presented in the Overview tab for each course. The examination language relates to the teaching language as follows:

- If teaching language is "Swedish", the course as a whole could be given in Swedish, or partly, or as a whole, in English. Examination language is Swedish, but parts of the examination can be in English.
- If teaching language is "English", the course as a whole is taught in English. Examination language is English.
- If teaching language is "Swedish/English", the course as a whole will be taught in English if students without prior knowledge of the Swedish language participate. Examination language is Swedish or English depending on teaching language.
